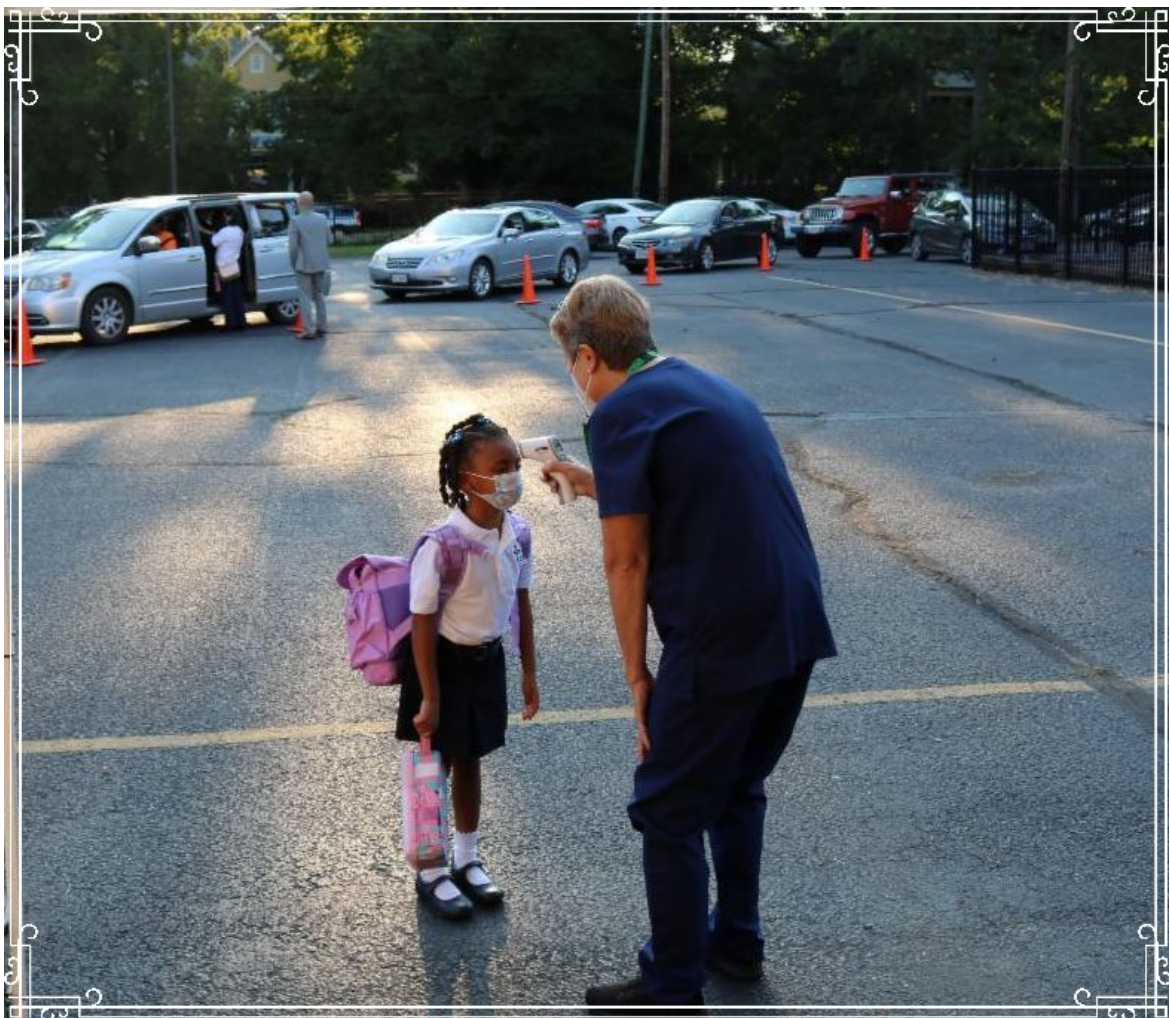

Construction has begun!

After waiting for a permit for eight months, construction finally

begins on All Saint's build-out this month!



The build-out, which will add three classrooms, a new front entrance and elevator, will revitalize our physical space by adding 6,800 square feet of learning and administrative space and configuring current areas to their best use.

If all goes as planned, we expect substantial completion by March 2021, with occupancy in the fall of 2021.

Thanks to the generosity of Weinstein Properties and many other donors, 93% of All Saints' ***The Future is Now!*** \$2.3+ million campaign has been funded. VIRGINIA'S EDUCATION IMPROVEMENT SCHOLARSHIPS TAX CREDITS



Virginia's Education Improvement Scholarships Tax Credits program provides scholarships for low-income new students to attend All Saints. Donors receive a Virginia ***tax credit equal to 65%*** of the donation. In addition to the 65% Virginia tax credit, donors may be eligible for additional federal and state deductions for these charitable contributions.

Here are some other points to note:

1. While a pledge to the program can be made now while assistance allocations are being made to students, a donor has up to 180 days (6 months) to make the donation, or until the end of December for credits in this tax year.
2. Donations of \$500 or more made with cash, check, credit card or gifts of stock are eligible for tax credits

To obtain tax credits for a scholarship donation under this program, donors must complete a [Letter of Intent](#) and [Preauthorization Form](#) prior to making a contribution.
